

# Holmes Chapel Fun Run

Sunday 11th May 2025 9.30am - 12 noon

### **EVENT INFORMATION**

Holmes Chapel Fun Run 2025 will take place on Sunday 11th May. The event will operate from 9.30am to 12 noon.

The event will take place at the Dane Meadow, with registration and meeting start points at the Daresbury Close entrance (near the viewing platform).

#### **ENTRANTS**

This event is for children aged 4 - 16 years old only. Children under 8 years of age must be accompanied along the route by an adult at all times. Adults do not need to register or pay to accompany children. We suggest a ratio of one adult to three children. For all other ages an adult should stay present in the area for the duration of the event while their child(ren) is still participating.

The standard route is approximately 2km and will have stewards at regular intervals to direct the way and point out potential hazards. The shorter accessible route is approximately 1km. We anticipate the 2km route should take around 45 minutes to complete.

# **REGISTRATION PROCESS & GUIDANCE**

The deadline for registration is Thursday 1st May to allow time to organise the final details of the event based on final numbers of participants.

Participants are required to pay a £2 entry fee each at time of registering. Registration must be done via the form on the Holmes Chapel Partnership website here: <a href="https://www.hcpartnership.org.uk/fun-run-registration">https://www.hcpartnership.org.uk/fun-run-registration</a>. Registration is not confirmed until the payment has been received in full. This fee covers costs relating to the Event. Any profits may be passed on to a local fundraising initiative.

### **RISK ASSESSMENTS & INSURANCE**

This event is being run by the Holmes Chapel Partnership which has comprehensive Public Liability Insurance. A risk assessment has been completed and submitted to Cheshire East as part of the event plan. (The Event is being held on Cheshire East land).

### AT THE EVENT

- Please register at the Event desks at the top of the Daresbury Close entrance to the Dane Meadow at least 15 minutes before your start time.
- Participants must be respectful of residents of Daresbury Close and the surrounding area. Please
  only park on Bramhall Drive, ensuring the road is kept clear for access for other traffic,
  including emergency vehicles.
- This event is being held outdoors with little shelter so please dress for the weather. Suitable shoes are required for the activity and terrain. Some areas can get muddy in wet weather.
- A moderate level of fitness is required, you can walk or run the route, but you will need to navigate steep slopes in some locations, which can get slippy when wet. Everyone taking part in the Event does so at their own risk.
- There are no toilets at the Dane Meadow. While there *may* be some refreshments on offer at the Event, we advise that you bring your own water bottle and drink with you.
- For safety reasons, please do not bring animals, even on leads, with you to the Fun Run. Exceptions will be made for service animals.
- A shorter accessible route will be available for anyone with mobility issues. Four disabled parking spaces are available at the Dane Meadow.
- Photographs may be taken at the event to be used on social media, on our website and in the press.
- Alcohol, tobacco, vapes and non-prescription drugs are strictly prohibited at the event.
- First Aid / Lost Child meeting points will be available at the Start on Daresbury Close and in the Dane Meadow.

## **SPECIAL NEEDS**

There are four spaces available for disabled parking at the Dane Meadow. A shorter wheelchair accessible route is available to allow all to participate. Please note that this is on gravel paths which may be uneven. Any persons who are unable to move independently must be accompanied by a companion who is able to provide any necessary assistance and take full responsibility accordingly.

### **TERMS AND CONDITIONS**

By completing and submitting the registration form you are confirming that you have read, accept and agree to be bound by the following terms and conditions:

Force Majeure Event: any event affecting the performance of any provision of this agreement arising from or attributable to acts, events, omissions, or accidents which are beyond the reasonable control of a party including any abnormally inclement weather, flood, lightning, storm, fire, explosion, earthquake, subsidence, structural damage, epidemic or other natural physical disaster, transport, disruptions, failure or shortage of power supplies, war, military operations, riot, crowd disorder, strike, lock-outs or other industrial action, terrorist action, civil commotion and any legislation, regulations, ruling or omission of any relevant government, court, competent national authority or governing body.

- 1. If you need to cancel your place for any reason please let us know but please note that there will be no refunds given.
- 2. Neither party shall be liable to the other under this agreement for any loss, damage, cost, expense, or other claim for compensation arising as a direct or indirect result or breach or non-performance of this agreement due to a Force Majeure Event.
- 3. Under no circumstances shall HCP be liable to You for any of the following, whether in contract, tort (including negligence) or otherwise
  - 3.1. any indirect or consequential losses.
  - 3.2. loss of revenue or anticipated revenue.
  - 3.3. loss of savings or anticipated savings.
  - 3.4. loss of business opportunity.
  - 3.5. loss of profits or anticipated profits; or loss of wasted expenditure
- 4. If the Event is cancelled for any reason (including, without limitation, by reason of a Force Majeure Event) HCP shall notify You of the cancellation as soon as possible. The parties agree that:
  - 4.1. HCP shall not be in breach of this agreement by virtue of that cancellation or abandonment.
  - 4.2. without prejudice to their rights and liabilities arising before this cancellation the parties shall, in respect of the period following the HCP's notice, thereafter, be relieved of their rights and obligations under this agreement in respect of the Event.
  - 4.3. HCP shall offer to You a refund if the reason for cancellation was an insured risk, foreseeable or under the control of HCP, subject to a 25% retention of the fees paid to cover administration and other Event costs.
- 5. Any notice or other communication required to be given to a party under or in connection with this contract shall be in writing and shall be delivered by email or text message to the details provided on registration.

- 6. This agreement and any dispute or claim arising out of or in connection with it or its subject matter (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.
- 7. Everyone taking part in the Event does so at their own risk.
- 8. The Event organisers and landowners assume no responsibility for anyone attending this event. The Event organisers will not be held responsible for any accident, injury or loss occurring as a result of participation or in connection with travel to such event, however caused.
- 9. Participants in this Event are reminded that outdoor activities frequently need specialist equipment (suitable footwear, waterproofs, etc) and the event organisers do not provide these. Participants are responsible for assessing their own risk, the safety of themselves and their guests and the suitability of any equipment used. Any Medical Conditions that may affect the participants during the Event should be notified to the Stewards prior to the start of the Event.
